Subject: CF6 Technical Manual Index February 1, 2012 Revision

This is the letter of transmittal for the February 1, 2012 revision of the CF6 Technical Manual Index. This revision supersedes and replaces all previous indices and revisions thereto in their entirety.

This index is issued monthly to define the status of CF6 publications and consists of the following parts:

Section 1	Component Maintenance Manuals - ATA Order
Section 2	Engine Manuals
Section 3	Ground Support Equipment Manuals

In the index, the "Rev. Cycle" column indicates the planned revision frequency for each publication listed. The meaning of entries in this column is as follows:

90	90 day (Quarterly)
120	120 day (3 times annually)
180	180 day (Semi-annual)
365	365 day (Annually)
AR	As Required (No Scheduled revisions - will be revised to incorporate changes as necessary)

Issue dates will be noted in the Next Rev Date column in the Engine Manual Index Section.

In the index, there is a "Rev. No." column used to indicate the current revision number of the CMM. When "AC" appears in the column the CMM is an Abbreviated "Component Maintenance Manual" and will not have a revision number.

An asterisks (\*) behind the revision number in the Rev. No. column shows that the document was revised since the last technical manual index was published.
