UPON DEFAULT BY THE SELLER IN PERFORMING ANY OF THE TERMS AND
CONDITIONS OF THIS PURCHASE ORDER, THE BUYER SHALL HAVE THE RIGHT
TO THE RETURN OF ALL PROGRESS PAYMENTS MADE BY THE BUYER TO THE
SELLER, AND THE RIGHT TO TAKE POSSESSION OF ALL PROPERTY IN WHICH
THE BUYER HAS A SECURITY INTEREST PURSUANT TO THE TERMS OF THIS
PURCHASE ORDER. BUYER SHALL HAVE THE SAME RIGHT TO TAKE POSSESSIO
