

## Information required to allow General Electric Company to process a DSP type license.

1. Legal entity name and complete addresses for your company as well as any other company sites that may be involved in this transaction.

**Example: XXX Technologies**  
**Full Street Address (no P.O. Box)**

2. Complete description of your role as a foreign party to this DSP type license.
3. Identify the foreign end user, as defined below including complete address.

Definition:

- The entity abroad that receives and ultimately uses the exported item. The end-user is not a forwarding agent or intermediary, but may be the purchaser or ultimate consignee.

**Example: The Government of Turkey**

4. Identify all foreign consignees, as defined below, involved in this transaction:

Definition:

- Individual, organization or agency, other than a bank or common carrier, specifically authorized by the ultimate consignee or foreign end-user to receive the defense articles on behalf of the foreign end-user, for storage, modification, or incorporation into another end-item, and who will eventually be responsible for forwarding the defense articles to the foreign end-user.

5. Identify all foreign intermediate consignees, as defined below, involved in this transaction.

Definition:

- Individual, organization or agency, other than a bank or common carrier, acting on behalf of the exporter, the purchaser or the foreign end user, for the purpose of receiving the goods in the foreign country and for forwarding them to the foreign end-user.

6. A Letter of intent is required for DSP type licenses.

See Attachment A for an example.

7. An End user Statement is required for DSP type licenses.

See Attachment B for an example.

9. Will this DSP type license require dual/third country national employees, as defined below, of the foreign licensees (including contract employees if applicable) to:

- (1) Have access to defense articles
- (2) Have access to/receive technical data, or
- (3) Receive or engage in defense services? If yes, list all relevant countries applicable to each foreign signatory (including contract employees as applicable)."

Definitions:

- Third Country National: An individual holding nationality from a country or countries other than the country of the foreign party identified in the DSP type license.
- Dual National: Holds nationality from the country of a foreign party and one or more additional foreign countries. Note: DoS considers both citizenship and country of birth when determining nationality.

If Yes, provide relevant countries applicable to each foreign signatory (includes contract employees if applicable).
